# YMCA 'GYMNASTICS ONE WEEK FREE PROMOTION' - TERMS AND CONDITIONS (Terms)

#### 1. OFFER AND ELIGIBILITY

- a. This 'Gymnastics One Week Free Promotion' (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Moonee Valley YMCA Gymnastics Club, Bellbird Park Indoor Centre, Boroondara Sports Complex, Phillip Island Leisure Centre and Macleod Recreation & Fitness Centre (Participating Centres) between the dates and times of 06:00am 10 February 2025 to 11:59pm on 3 March 2025 (Promotion Period).
- d. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

#### 2. SIGN UP TERMS

- a. Participants are eligible for one week of free gymnastics classes when sign up occurs during the Promotional Period. A credit will be applied to your account prior to the first debit once you have signed up.
- b. This Promotion is not applicable to existing gymnastic class members.
- c. The Promotion is only available at the Participating Centres.
- d. The Promotion requires a minimum commitment of 8 weeks.
  - i. If cancellation is requested within this period, there is a 2-week cancelation policy and your membership will end 14 days after it has been approved. Your enrolment will be deemed active until notified by the centre staff and have received official confirmation from the facility the cancelation has been processed.
