

## YMCA 'May MOVES' - TERMS AND CONDITIONS (Terms)

### 1. OFFER AND ELIGIBILITY

- a. This 'May MOVES' promotion (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Bass Coast Aquatic and Leisure Centre, Phillip Island Leisure Centre, between the dates of 12 May to 8 June 2025 (**Promotion Period**).
- d. To be eligible for the Promotion:
  1. You must be an existing Health and Wellness member at a relevant Participating Centre;
  2. Or you must become a Health and Wellness member at a Participating Centre within the Promotion Period.
  3. Participants must have an active Technogym account and ensure MOVEs are logged during the competition period.
  4. Participants must enter into the "May Moves" challenge through the Techno Gym App.
- e. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

### 2. COMPETITION TERMS

- a. If you meet the criteria set out in clause 1(d), you will be eligible for a chance to win the prizes outlined in these terms.
- b. To qualify, you must be 18+ years old.
- c. The Promotion is only available at Participating Centres.
- d. There is no minimum number of MOVEs required – any moves logged during the competition dates enables participation.
- e. All other applicable fees and charges in respect of membership (new or existing) will be payable in accordance with the applicable membership terms. Your membership will otherwise be governed by such membership terms.
- f. Employees of YMCA and their immediate families are not eligible.

- a. **Major Prize – Performance Winner:** The eligible member with the most MOVEs logged at Bass Coast Aquatic and Leisure Centre, Phillip Island Leisure Centre, will receive a merchandise pack valued at \$100.
